

Purpose & Scope

This Code applies to all individuals engaged with Odak NGO (Odak Derneği), including staff, volunteers, consultants, and implementing partners.

Its purpose is to:

- Promote a unified culture of ethics. respect, and accountability.
- Protect the rights, dignity, and safety of those we serve.
- Prevent misconduct, abuse of power, and misuse of resources.
- Guide decision-making in alignment with Odak's humanitarian mission.



All Odak representatives are required to:

- Read, understand, and commit to this Code.
- Follow all related policies and procedures.
- Report any breaches to the Legal and Compliance Committee.

Acting with Integrity & **Accountability**

Fraud, Bribery, and Corruption

Odak NGO has a zero-tolerance policy toward any form of fraud, bribery, or corruption. Such acts violate not only the law but also our humanitarian mandate.

- Do not offer or accept bribes, kickbacks, or facilitation payments.
- Ensure that funds, donations, and aid resources are used solely for their intended purpose.
- Report any suspected misconduct immediately to the Legal and Compliance Committee.

Gifts and Hospitality

Any gifts, hospitality, or favors must never compromise professional judgment or create the appearance of bias.

- Seek prior written approval before offering or accepting gifts.
- Decline any gesture that could influence or appear to influence decision-making.

Conflict of Interest

Objectivity and impartiality are essential to Odak's credibility.

- Disclose any personal, financial, or family relationships that may affect impartiality.
- Avoid situations that could create a real or perceived conflict of interest.

Respect for Human Rights & Dignity

Equality, Diversity, and Non-Discrimination

Odak promotes equality and inclusion for all. Discrimination, harassment, and abuse are incompatible with our mission.

- Treat every person with dignity and empathy.
- Respect cultural differences while upholding universal human rights.
- Report any form of harassment, discrimination, or bullying immediately.

Safeguarding and Child Protection

Odak is committed to creating a safe environment for children, women, and vulnerable adults.

- Sexual exploitation, abuse, and harassment (SEA) are strictly prohibited.
- No staff or representative may engage in sexual relationships with beneficiaries or exchange goods, services, or favors for sex.
- Report any safeguarding concerns confidentially.

Human Trafficking and Exploitation

Odak opposes all forms of forced labor, modern slavery, and human trafficking.

- Remain alert to indicators of exploitation in Odak's operations or partners' activities.
- Report concerns through the appropriate channels.

Data Protection and Privacy

Odak respects privacy and complies with national and international data protection standards.

- Collect and store personal data only when necessary and lawfully.
- Keep sensitive information secure and confidential.
- Report data breaches immediately to the Legal and Compliance Committee.

Use of Technology and Communication

- Use organizational technology, email, and digital tools ethically and professionally.
- Do not engage in illegal, offensive, or discriminatory online behavior.

Confidential and Sensitive Information

Information shared with Odak by donors, partners, or beneficiaries must remain protected.

- Never share, reproduce, or misuse confidential materials without authorization.
- Notify the Legal and Compliance Committee if a breach of confidentiality occurs.

Partnerships, Procurement & Funding Integrity

Odak NGO builds partnerships based on fairness, transparency, and mutual respect.

- Conduct due diligence before partnering or contracting.
- Ensure procurement and purchasing processes are impartial, documented, and auditable.
- Use donor funds responsibly, following both internal and donor-specific requirements.
- Promote environmental responsibility in every project by minimizing waste and resource use.

Financial transparency is essential to our legitimacy and sustainability. All expenditures, grants, and donations must be recorded accurately and verifiably.

Healthy and SafeWorking Environment

- Participate in training related to safety, mental health, and well-being.
- Respect work-life balance and create an environment that fosters trust and collaboration.

Odak encourages open communication and the courage to speak up. Anyone who suspects a breach of this Code or other misconduct must report it through one of the following:

- The Legal and Compliance Committee, or
- The Confidential Whistleblowing E-mail.

All reports are handled sensitively, investigated fairly, and treated with strict confidentiality.

Non-Retaliation Guarantee:

Odak NGO prohibits any retaliation against individuals who report concerns in good faith. Anyone found retaliating will be subject to disciplinary action by the Board of Directors and oversight from the Supervisory Board.
